1. POLICY STATEMENT

ANIT Australia Pty Ltd, trading as Albright Institute of English, and Albright Institute of Business and Language (both hereafter may be referred to as **Albright Institute** or **AIBL**), is committed to responsible and ethical admissions practices that ensure every prospective student is genuinely suited to the course in which they seek to enrol. This policy establishes a transparent, consistent and fair framework for assessing the suitability of applicants for all courses offered by Albright Institute.

Albright Institute acknowledges that admitting students who are not adequately prepared for their chosen course adversely affects student wellbeing, course completion rates and the integrity of qualifications delivered. Entry requirements are therefore both a regulatory obligation and a student welfare measure.

This policy operates in accordance with the following legislative and regulatory frameworks:

- 2025 Outcome Standards for NVR Registered Training Organisations (the 2025 Outcome Standards), in particular Standards 2.1, 2.2, 1.1, 1.2, 2.4, 2.5, and 4.3;
- National Vocational Education and Training Regulator (Compliance Standards for NVR Registered Training Organisations and Fit and Proper Person Requirements) Instrument 2025 (the 2025 Compliance Standards);
- Education Services for Overseas Students (ESOS) Act 2000 and the ESOS Regulations 2019;
- National Code of Practice for Providers of Education and Training to Overseas Students 2018 (the National Code 2018), in particular Standards 1, 2, 3, 5, and 11;
- ELICOS Standards 2018, made under subsection 22(1) of the ESOS Act 2000, governing the delivery of ELICOS courses to overseas students;
- Migration Act 1958 and the Migration Regulations 1994;
- Australian Consumer Law (Schedule 2 of the Competition and Consumer Act 2010);
- Disability Discrimination Act 1992 and the Disability Standards for Education 2005;
- Privacy Act 1988 (Australian Privacy Principles); and
- Student Identifiers Act 2014.

2. PURPOSE

The purpose of this policy and its associated procedure is to:

- 2.1. establish clear, consistent and transparent entry requirements for all courses delivered by Albright Institute to both domestic and international students;
- 2.2. ensure that all applicants are assessed fairly and ethically against defined criteria before an offer of enrolment is made;
- 2.3. meet Albright Institute's obligations under Standard 2.2 of the 2025 Outcome Standards, Standard 2 of the National Code 2018 and all other applicable legislative and regulatory frameworks;

- 2.4. protect student welfare by ensuring students undertake courses appropriate for their skills, language proficiency, educational background and study objectives;
- 2.5. provide admissions staff and education agents with clear guidance on how to assess, verify and process applications; and
- 2.6. support the integrity of the Australian student visa system by ensuring that only eligible, well-informed and appropriately qualified students are enrolled.

3. SCOPE

This policy applies to:

- 3.1. all prospective and current students of Albright Institute, including domestic and international students;
- 3.2. all ELICOS (English Language Intensive Courses for Overseas Students) and VET (Vocational Education and Training) courses on Albright Institute's scope of registration and being offered by the Albright Institute;
- 3.3. all Albright Institute staff involved in admissions, enrolment, marketing and compliance; and
- 3.4. all authorised education agents who represent Albright Institute in recruiting prospective students.

4. DEFINITIONS

AQF means Australian Qualifications Framework; the national policy for regulated qualifications in Australian education and training.

CRICOS means Commonwealth Register of Institutions and Courses for Overseas Students; the official register of providers approved to deliver courses to student visa holders in Australia.

CoE means Confirmation of Enrolment; an electronic document issued through PRISMS confirming a student's acceptance into a CRICOS-registered course.

DHA means Department of Home Affairs; the Australian Government agency responsible for student visa policy and administration.

ELICOS means English Language Intensive Courses for Overseas Students; English language programs delivered to international students under the ELICOS Standards 2018.

ELICOS Standards 2018 means the Education Services for Overseas Students (ELICOS Standards) Instrument 2018, which sets out the standards for providers delivering English Language Intensive Courses for Overseas Students, and which operates alongside the National Code 2018 for CRICOS providers delivering ELICOS programs.

Genuine Student (GS) means the assessment framework applied by the Department of Home Affairs to determine whether a student visa applicant is genuinely seeking to study in Australia. Albright Institute applies due diligence in supporting the integrity of this assessment.

IELTS means International English Language Testing System, one of the accepted standardised English language proficiency tests.

Letter of Offer means the formal document issued to a prospective student that sets out the course details, the entry conditions met, the fees, the duration, and the terms on which the offer is made.

LLND Assessment means Language, Literacy, Numeracy and Digital Literacy Skills assessment; a mandatory pre-commencement assessment conducted for all VET students to identify support needs and confirm readiness for the training product.

NEAS means the National ELT Accreditation Scheme, the quality assurance body for English Language Teaching in Australia. Albright Institute is accredited by NEAS and its ELICOS delivery is subject to the NEAS Quality Assurance Framework.

OSHC means Overseas Student Health Cover; the health insurance required by the Australian Government for all student visa holders studying in Australia.

PRISMS means Provider Registration and International Student Management System; the secure government system used to issue CoEs and report student information.

Pre-Training Review (PTR) means a structured process conducted at or before enrolment to assess the prospective student's skills, knowledge, and characteristics relevant to the course, and to advise them on suitability.

Training product means an AQF qualification, skill set, unit of competency, accredited short course or module.

USI means Unique Student Identifier; a reference number enabling all VET students to access their national VET transcript via the USI registry.

VET means Vocational Education and Training; nationally recognised training delivered against Australian training packages or accredited courses.

Written Agreement means the legally binding agreement between Albright Institute and the student that sets out the services to be provided, fees payable, refund arrangements, and obligations of both parties, as required under the National Code 2018.

5. STUDENT SELECTION PRINCIPLES

All admissions decisions at Albright Institute are guided by the following principles:

- 5.1. **Ethical and responsible recruitment:** Albright Institute recruits students in an honest, transparent and consistent manner with students' best educational interests. Marketing and communications must not be false or misleading, in accordance with Standard 1 of the National Code 2018 and Australian Consumer Law.
- 5.2. **Informed decision-making:** Prospective students must receive clear, accurate and accessible information about entry requirements, course content, fees, duration and obligations before they make any commitment to enrol. This obligation arises from Standard 2.1 of the 2025 Outcome Standards and Standard 2 of the National Code 2018.
- 5.3. **Individual suitability assessment:** Each application is assessed individually against the documented entry requirements for the course applied for. Blanket decisions or assumptions based on nationality, background or agent recommendation without proper assessment of individual evidence are not acceptable.
- 5.4. **Fairness and non-discrimination:** Entry requirements are applied consistently and without unlawful discrimination on the basis of disability, race, sex, age, national origin, religion or any other protected attribute under Australian law. Where a prospective student has a disability, Albright Institute will consider whether reasonable adjustments can be made to support their participation, in accordance with the Disability Standards for Education 2005 and Standard 2.4 of the 2025 Outcome Standards.
- 5.5. **Integrity of the student visa system:** Albright Institute enrolls students whose study intentions are consistent with the requirements of the Australian student visa. Albright Institute will not knowingly enrol students whose application appears to be for purposes other than genuine study in Australia.
- 5.6. **Privacy and confidentiality:** All personal information collected from applicants during the admissions process is handled in accordance with the Privacy Act 1988 and Albright Institute's Privacy Policy.

6. GENERAL ENTRY REQUIREMENTS

The following general entry requirements apply to all prospective students seeking enrolment in any course at Albright Institute, unless otherwise specified in Section 9 (Course-Specific Entry Requirements).

6.1. Minimum Age

All applicants must be at least 18 years of age at the time of course commencement. Albright Institute does not enrol students under the age of 18 into any of its programs.

6.2. Academic Qualifications

Applicants must demonstrate completion of the relevant academic qualification as set out in the course-specific entry requirements in Section 9. For most VET qualifications, this is the Australian equivalent of Year 12 or Year 11, depending on the qualification's AQF level.

Refer to Appendix A for the list of international academic qualifications considered equivalent to Australian Year 11 and Year 12.

Academic qualifications presented by applicants must be:

- original or certified copies of certificates, transcripts, or completion records;
- translated into English by a NAATI-accredited translator if the originals are in a language other than English; and
- verified for authenticity by Albright Institute admissions staff before an offer of enrolment is made.

6.3. Student Visa

International applicants must hold, or be in the process of obtaining, a valid Australian Student Visa (Subclass 500) that permits study at the AQF level of the course for which they are applying. Albright Institute will not issue a Confirmation of Enrolment (CoE) until the conditions required for the visa are satisfied or are in the process of being satisfied.

6.4. Unique Student Identifier (USI)

All students undertaking nationally recognised VET training in Australia are required by law to hold a valid USI. Applicants who do not already have a USI must obtain one before commencement. Albright Institute may assist students in obtaining their USI with their consent, in accordance with the Student Identifiers Act 2014. The USI requirement does not apply to students enrolled in ELICOS courses only.

6.5. Computer Literacy

Given that training and assessment at Albright Institute are conducted using digital platforms and tools, all VET applicants are expected to have a basic working knowledge of computers and commonly used software applications, including word processing, spreadsheet, and presentation software. This requirement is assessed as part of the LLND (Language, Literacy, Numeracy and Digital Literacy Skills) assessment and Pre-Training Review processes described in Sections 8 (LLND) and 11 (PTR).

6.6. Overseas Student Health Cover (OSHC)

International students are required to hold and maintain Overseas Student Health Cover (OSHC) for the full duration of their enrolment in Australia, as required under the student visa conditions. Evidence of current OSHC must be provided to the Albright Institute before a CoE is issued.

7. ENGLISH LANGUAGE PROFICIENCY REQUIREMENTS

All international applicants seeking enrolment in a VET course at Albright Institute must demonstrate a minimum level of English language proficiency appropriate to the demands of the course. English-language requirements are set at the course level and specified in Section 9.

For ELICOS applicants, English language proficiency is assessed through the AIBL ELICOS Placement Test as described in Section 9.1 of this policy and the Albright ELICOS Student Journey Policy and Procedure. The

requirements in this section relating to minimum proficiency levels and accepted test evidence apply to VET course entry.

7.1. Accepted Evidence of English Language Proficiency

Albright Institute accepts the following as evidence of English language proficiency for VET course entry:

- **IELTS Academic or General:** minimum overall band score as specified per course (score must be within two calendar years of application);
- **Pearson Test of English (PTE Academic):** minimum overall score as specified per course (within two calendar years);
- **Cambridge English Qualifications:** minimum score as specified per course (within two calendar years);
- **TOEFL iBT:** minimum score as specified per course (within two calendar years);
- **Certificate of completion of an Albright Institute ELICOS course:** at the exit level specified for the relevant VET course (General English Upper-Intermediate or equivalent), issued within 2 years of application; or
- **AIBL English Level Assessment Test for VET:** achieving the threshold level specified for the relevant course, administered by Albright Institute, where other evidence is unavailable or has expired.

7.2. Exemptions from English Language Proficiency Evidence

The following applicants are exempt from providing a standardised English language test result for VET course entry, provided they satisfy one of the conditions below. All exempt applicants remain required to complete the LLND Assessment (Section 8):

- applicants who are citizens of, and hold a valid passport issued by, the United Kingdom, the United States of America, Canada, New Zealand, or the Republic of Ireland;
- applicants who have, within the three calendar years preceding their application, successfully completed the requirements for a Senior Secondary Certificate of Education in a course conducted entirely in English in Australia; or
- applicants who have successfully completed a minimum of five continuous years of study conducted in English in one or more of the following countries: Australia, Canada, New Zealand, South Africa, the Republic of Ireland, the United Kingdom, or the United States of America; or
- applicants who have, within the three calendar years preceding their application, successfully completed an Australian qualification of minimum AQF Level 3 (Certificate III) or higher at Albright Institute or any other Australian RTO.
- applicants who have completed a course at Albright Institute and are immediately commencing another subsequent course.

Note: Exemption from providing an English language test result does not exempt any applicant from completing the mandatory LLND Assessment prior to course commencement. The LLND Assessment is mandatory for all VET students regardless of English proficiency status.

7.3. English Language Assessment Scenarios

The following scenarios describe how English language proficiency is assessed in common application situations:

Scenario	Applicant Situation	Action
Scenario 1	Applicant has a valid IELTS/PTE/Cambridge/TOEFL result that meets the minimum requirement for the course applied for.	English proficiency confirmed. Proceed to LLND Assessment. Issue a Letter of Offer with no English condition.
Scenario 2	Applicant has an English language result that has expired (more than two calendar years old) or doesn't meet the minimum requirement.	Administer the AIBL English Level Assessment Test for VET. If the result is at the required level, proceed. If below, refer to the ELICOS pathway.
Scenario 3	The applicant has no English language test result, and no exemption applies.	Administer the AIBL English Level Assessment Test for VET. If the result meets the required level, proceed to LLND Assessment. If below, advise the student of the ELICOS pathway option.
Scenario 4	Applicant applies for a packaged ELICOS + VET program.	Administer the AIBL ELICOS Placement Test to determine the appropriate English level class. The student must complete the ELICOS component and attain the required exit level before commencing VET.
Scenario 5	The applicant has completed a previous AQF qualification (minimum AQF Level 3 or higher) at Albright Institute or any Australian RTO within the last 3 years.	Administer the LLND Assessment at the level of the new qualification. This is mandatory regardless of prior study in Australia, except where a student is immediately commencing the subsequent course at Albright Institute.
Scenario 6	Applicant is an ELICOS applicant providing a valid IELTS/PTE/Cambridge test result.	Use the test result to place the student in the appropriate English language level class consistent with the ELICOS Placement framework.

Scenario	Applicant Situation	Action
Scenario 7	Applicant is an ELICOS applicant with no English test result.	Administer the AIBL ELICOS Placement Test on Orientation Day to place the student in the appropriate class.

8. LANGUAGE, LITERACY, NUMERACY AND DIGITAL LITERACY SKILLS (LLND) ASSESSMENT

The LLND Assessment is a mandatory requirement for all students enrolling in a VET qualification at Albright Institute. It is conducted in accordance with Standard 2.2(a) of the 2025 Outcome Standards, which requires the RTO to have procedures for reviewing prospective students’ language, literacy, numeracy and digital literacy skills prior to enrolment.

8.1. Purpose of the LLND Assessment

The LLND Assessment is not a pass/fail admission test. Its purpose is to:

- identify each student’s current LLND capabilities relative to the demands of the training product;
- inform Albright Institute’s decision on whether the course is suitable for the student;
- identify where LLND support services may be needed to enable the student to successfully complete the qualification; and
- guide the development of a personalised study plan for the student.

8.2. LLND Assessment Requirements

- The LLND Assessment must be completed by every student enrolling in a VET qualification, without exception.
- For students enrolling in a packaged program (e.g., ELICOS + VET, or multiple qualifications), the LLND Assessment is administered at the AQF level of the first VET qualification in the program.
- The LLND Assessment must be fully completed. If any component is missed, the student will be required to complete the missing section before the assessment is finalised.
- The assessment may be administered prior to Orientation Day or on Orientation Day itself. Students must not commence training until the LLND Assessment is complete and the results are recorded.
- Where the assessment identifies that a student requires LLND support, Albright Institute will outline the support measures available and incorporate them into the student’s study plan. The identification of a support need does not automatically result in refusal of enrolment, but it must be addressed before or at commencement.

8.3. Exemptions from the LLND Requirements

- If a student has completed a nationally recognised training course in Albright, or another RTO in Australia, at least to the AQF level or one level below the qualification they are seeking to enrol, and they are seeking to commence the qualification at Albright without any study gap, an LLND assessment is not required in that case.
- If a student is seeking to enrol in a short course or one-day course, Albright may assess the student's language, literacy, numeracy and digital literacy skills through a basic assessment process instead of the full LLND assessment kit.

Note: The LLND Assessment applies to VET students only, including those exempt from providing English test results under Section 7.2, and those who have previously studied at Albright Institute but are not commencing the next course immediately. ELICOS students do not undergo an LLND Assessment. Class placement for ELICOS students is determined by the AIBL ELICOS Placement Test, in accordance with the Albright ELICOS Student Journey Policy and Procedure.

9. COURSE-SPECIFIC ENTRY REQUIREMENTS

The following tables set out the entry requirements for each course currently delivered by Albright Institute. These requirements are applied in addition to the general entry requirements in Section 6.

9.1. VET Courses

The following entry requirements apply to all VET courses. The Training and Assessment Strategy document for each VET course also contains detailed course-specific entry requirements aligned with this policy.

The general entry requirements for all VET courses are:

- Minimum 18 years of age at commencement;
- Academic qualification at the Australian equivalent level specified per course (see column 'Academic Requirement' below);¹
- English language proficiency as specified per course (see column 'Minimum English' below), within two calendar years of application;²
- Basic computer usage skills;
- Valid Student Visa (Subclass 500) permitting VET study, or confirmation that one will be granted before commencement;

¹ Refer to Appendix A for the list of international academic qualifications considered equivalent to Australian Year 11 and Year 12.

² For applicable exemptions from the English Language proficiency requirements, please refer to Section 7.2 of this document.

- Completion of the LLND Assessment; and
- Satisfaction of the Pre-Training Review (PTR) requirement.

9.2. ELICOS Courses

The general entry requirement for all ELICOS courses is at least 18 years of age at the commencement of the ELICOS course. No academic qualification beyond the minimum age is required for entry to the ELICOS course at Albright Institute.

The AIBL ELICOS Placement Test determines the appropriate class level for each student in accordance with the ELICOS Mapping framework set out in the Albright ELICOS Student Journey Policy and Procedure. The class placement process, level structure and progression requirements are governed by the Albright ELICOS Student Journey Policy and Procedure, which is the primary reference document for ELICOS course delivery at Albright Institute.

However, the test scores of various English proficiency tests are also an accepted alternative to the AIBL ELICOS Placement Test. Refer to the ELICOS Mapping table in the Albright ELICOS Student Journey Policy and Procedure for applicable score thresholds.

10. DOCUMENT VERIFICATION AND AUTHENTICATION

Meeting entry requirements is not a self-declared process. Albright Institute requires independent verification of all evidence before an offer of enrolment is made. The following standards apply to all documents submitted in support of an application:

- 10.1. All academic transcripts and certificates must be original documents or certified true copies. Uncertified photocopies or scanned copies are not accepted unless the originals are sighted and certified by an authorised Albright Institute staff member.
- 10.2. All documents in a language other than English must be accompanied by a certified translation prepared by a NAATI-accredited translator.
- 10.3. English language test results must be verified as genuine by checking the test provider’s online verification system, where available (e.g., IELTS Test Report Form verification at ielts.org, PTE score verification at pearsonpte.com).
- 10.4. Passport details must be verified for authenticity and currency. An expired passport is not acceptable as proof of identity.
- 10.5. Where there are grounds to doubt the authenticity of any document, the Admissions Team must escalate the matter to the Compliance Manager before the application proceeds. Applications with fraudulent or suspected fraudulent documentation must be declined and referred to the CEO.
- 10.6. Records of all verification steps taken must be documented and retained in the student’s file.

11. PRE-TRAINING REVIEW (PTR)

A Pre-Training Review (PTR) is a structured assessment, including interview/s if necessary, conducted with each prospective VET student prior to enrolment. It is a requirement of the 2025 Outcome Standards (Standard 2.2) and forms the foundation of Albright Institute’s obligation to assess the suitability of the training product for each student.

11.1. PTR Components

The PTR covers the following dimensions:

- 11.1.1. Training objectives: what vocational outcomes the student is seeking and whether the chosen course aligns with those objectives;
- 11.1.2. Current skills and knowledge: the student's existing skills, knowledge, and prior learning relevant to the course, including consideration of whether credit transfer or RPL may be applicable (refer to the Albright Credit Transfer and RPL Policy and Procedure);
- 11.1.3. LLND proficiency: the student's language, literacy, numeracy, and digital literacy skills capabilities relative to the training product demands, assessed through the LLND Assessment (Section 8);
- 11.1.4. Support needs: whether the student requires any learning support, wellbeing support, or reasonable adjustments to participate in training and assessment on an equal basis; and
- 11.1.5. Course suitability advice: based on the above, Albright Institute provides each prospective student with an informed recommendation on whether the training product is suitable for them, including any conditions or support arrangements.
- 11.1.6. Genuine student assessment (international VET applicants only): the student's study intentions, understanding of course obligations and any factors relevant to their genuine intention to study in Australia, in support of Albright Institute's due diligence obligations under the ESOS Act and National Code 2018.

11.2. Outcome of PTR

Following the PTR, one of the following outcomes is recorded:

- 11.2.1. Suitable to proceed: the student meets all requirements, and the course is appropriate. A Letter of Offer is prepared.
- 11.2.2. Suitable to proceed with support: the student meets requirements but has identified support needs. The Letter of Offer is issued with a note that support arrangements will be put in place at commencement.
- 11.2.3. Conditionally suitable: the student has not yet met one or more requirements (e.g., IELTS result outstanding, final transcript pending). A conditional Letter of Offer may be issued, specifying the outstanding condition (s).
- 11.2.4. Not suitable: the student does not meet the entry requirements, or the course is not appropriate for their needs. The application is declined, and the student is advised in writing with reasons and, where applicable, information about alternative pathways or referral options.

Note: *The Pre-Training Review requirement applies only to VET courses. ELICOS students are not subject to a PTR. The enrolment and class placement process for ELICOS students is governed by the Albright ELICOS Student Journey Policy and Procedure.*

12. GENUINE STUDENT CONSIDERATIONS

Albright Institute supports the integrity of the Australian student visa system. In addition to assessing academic and English language entry requirements, Albright Institute incorporates a genuine student assessment into the Pre-Training Review (PTR) process, conducted with each international VET applicant prior to enrolment, to assess their study intentions and other eligibility factors.

As part of the PTR, the genuine student assessment is designed to:

- 12.1. confirm the student's study goals and how the chosen course aligns with their educational and career objectives;
- 12.2. assess whether the student has sufficient understanding of the course demands, duration, and obligations;
- 12.3. identify any circumstances that may affect the student's ability to complete the course; and
- 12.4. gather information relevant to the student's genuine intention to study in Australia.

Genuine student assessment outcomes and notes must be documented in the PTR record and retained in the student's file. The Student Services Manager reviews the PTR outcome, including the genuine student assessment, as part of the admissions decision.

Note: While the Genuine Student assessment is formally conducted by the Department of Home Affairs as part of the visa application process, Albright Institute is responsible for exercising due diligence in its own admissions practices. Admitting students whose study intentions are clearly inconsistent with the course or with Australian visa obligations may expose Albright Institute to significant regulatory risk.

13. DECISIONS ON APPLICATIONS

13.1. Offer of Enrolment

Where an application meets all entry requirements and, for VET applications, the PTR confirms suitability, Albright Institute will issue a Letter of Offer and Written Agreement to the applicant. The Letter of Offer and Written Agreement must include:

- 13.1.1. course name, CRICOS code, and provider code;
- 13.1.2. course duration, intake date, and delivery mode;
- 13.1.3. all applicable fees, payment schedule, and refund terms;
- 13.1.4. entry requirements confirmed as met;
- 13.1.5. any conditions of the offer that remain outstanding;
- 13.1.6. the student's rights under Australian Consumer Law;
- 13.1.7. Tuition Protection Service (TPS) information;
- 13.1.8. OSHC requirements;

- 13.1.9. student obligations, including notification of change of address; and
- 13.1.10. information about the complaints and appeals process.

The student (or their authorised representative) must sign and return the Written Agreement, and the initial tuition fee must be received into Albright Institute's designated protected account, before a CoE is issued.

13.2. Conditional Offer

Where an applicant has not yet provided all required evidence but otherwise appears to meet entry requirements, Albright Institute may issue a conditional Letter of Offer specifying the outstanding conditions that must be satisfied before a CoE can be issued. Outstanding conditions must be resolved before the study commences.

13.3. Refusal of Application

Where an application does not meet entry requirements, Albright Institute will decline the application and advise the applicant in writing, including:

- 13.3.1. the specific reason(s) for the decision;
- 13.3.2. information about the applicant's right to appeal the decision in accordance with Albright Institute's Complaints and Appeals Policy; and
- 13.3.3. where applicable, information about alternative study pathways (e.g., ELICOS program, lower-level qualification, or deferred entry pending completion of outstanding requirements).

14. STUDENT RIGHTS AND OBLIGATIONS

14.1. Student Rights

All prospective and enrolled students have the right to:

- 14.1.1. receive clear, accurate, and complete information about entry requirements before submitting an application;
- 14.1.2. be assessed fairly, consistently, and without unlawful discrimination;
- 14.1.3. receive written notification of any decision on their application, including the reasons for any refusal;
- 14.1.4. receive information about alternative pathways where an application is unsuccessful;
- 14.1.5. appeal any admissions decision in accordance with Albright Institute's Complaints and Appeals Policy; and
- 14.1.6. have their personal information handled in accordance with the Privacy Act 1988 and Albright Institute's Privacy Policy.

14.2. Student Obligations

Prospective students are responsible for:

- 14.2.1. providing complete, accurate, and authentic documentation in support of their application;
- 14.2.2. disclosing any circumstances that may affect their ability to meet the entry requirements or complete the course;
- 14.2.3. completing all required pre-enrolment assessments, including the LLND Assessment and Pre-Training Review (PTR);
- 14.2.4. reviewing all pre-enrolment information provided, including the Student Handbook, course brochure, and Written Agreement, before signing; and
- 14.2.5. notifying Albright Institute of any change to their contact details or circumstances that may affect their enrolment.

15. RESPONSIBILITIES

Must not accept, assess, or make representations about applications outside the scope of their written agreement with Albright Institute.
All Staff	Must direct prospective students to the Admissions Department for entry requirement enquiries. Must not provide informal advice on entry requirements that differ from this policy. Must maintain confidentiality of applicant information.

16. RECORDS MANAGEMENT

The following records must be retained on the student's electronic files across the Student Management System (SMS), Learning Management System (LMS), and relevant SharePoint folder:

- 16.1. completed Student Application Form with signed student declaration;
- 16.2. certified copies of all academic qualifications and transcripts;
- 16.3. evidence of English language proficiency (test results, ELICOS completion certificate, or AIBL assessment result);
- 16.4. copy of passport (photo and signature pages);
- 16.5. verification records for all documents (staff notes confirming sighting of originals, online verification records, or NAATI translation certificates);
- 16.6. LLND Assessment results and any identified support plan;
- 16.7. PTR records, including genuine student assessment notes and outcome;
- 16.8. Letter of Offer, Written Agreement (signed), and any conditional offer correspondence;
- 16.9. evidence of initial fee payment into the protected account;
- 16.10. Confirmation of Enrolment (CoE) issued via PRISMS; and
- 16.11. any refusal notice, appeal records, or variation correspondence.

In accordance with the ESOS Act and Standard 3 of the National Code 2018, enrolment-related records for international students must be retained for a minimum of two years after the student ceases to be an accepted student. Records must be stored securely, with appropriate access controls, and must be retrievable for audit purposes.

For domestic students, records are to be retained in accordance with Albright Institute's Student Record Retention Policy and the minimum requirements of the 2025 Outcome Standards.

17. ENTRY REQUIREMENT IMPLEMENTATION PROCEDURE

Note: The admissions procedure set out in this section in full applies to VET course applications.

For ELICOS course admissions, Steps 6 (LLND Assessment), 7 (PTR), and related sub-steps do not apply. ELICOS class placement is determined by the AIBL ELICOS Placement Test, which is administered on Orientation Day or at enrolment in accordance with the Albright ELICOS Student Journey Policy and Procedure.

All other steps; document verification, application assessment, Letter of Offer, Written Agreement, CoE issuance and records management, apply equally to ELICOS enrolments.
